TUITION

Tuition is charged on a monthly basis and payment of fees is due by the fifth of each month. Tuition is paid upon enrollment and not refundable upon withdrawal. A pro-rated fee of your daily rate will take place each month for the days we are not opened. The tuition that is quoted is based on a twenty working day month. If we are closed your monthly tuition will be less for that month, if the closing day lands on the day your child is scheduled to come. If there are over twenty days in one calendar month and your child is scheduled to come in on the extra day, you will be charged your daily rate for the extra day.

TUITION & ABSENCES

Operational expenses continue whether the child is present or absent. Consequently, no adjustments will be made for absences of less than 5 consecutive days. After 5 consecutive days of illness or vacation a credit will be given at the rate of one-half the daily tuition from the 6th day only.



TUITION AND WITHDRAWING YOUR CHILD

We ask parents to notify the center 1 week before withdrawing their child from the center. Parents who fail to notify the center that their child will no longer be enrolled will be charged the regular fees up to one week of absence. After one week of absence they will be considered no longer enrolled.

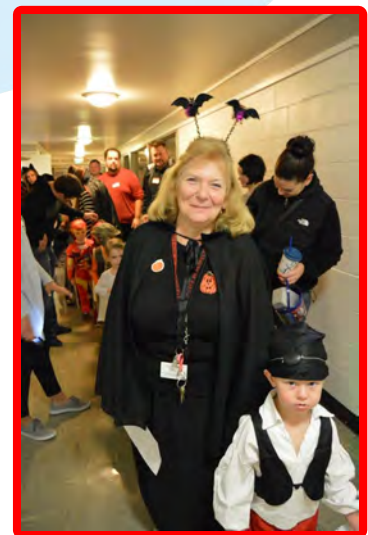
PAYMENT OF FEES

LATE FEES

Tuition not made by the 5th of each month will be charged at a rate of **\$1.00** a day and if not paid in a 2 week period, constitutes withdrawal of the child from the program, unless you have made prior **arrangements ahead of time** with the Director. NSF fee for all returned checks is **\$25.00**.

Please phone the center if you are going to be late picking them up so we can let your child know. There will be a late fee of **\$5.00 for each 10 minute block over your pick up time**. Our center runs on a schedule that requires nap times and lunches for other children and prompt departure so your cooperation will be appreciated.
